If you wish to consider standing for the Board, nomination forms are available at the Club, or below. The form should be signed by the member agreeing to be nominated and by two other Life or Associate PBC members.

The timeframes are as follows:

- All nominations for Board positions must be received by **3pm on 3 November 2024** at the club.
- Nominations will be posted on the noticeboard as received.
- Nominations can be delivered by hand to the club or emailed to enquiries@thepbc.org.au

A copy of the Articles of Association for the Club is available on request.

Answers to Frequently Asked Questions are as follows:

- The Articles of Association allow for additional nominations and an election to be conducted during the AGM should there be an insufficient number of nominations prior to the AGM.
- The Articles of Association specify that all positions are declared vacant at the AGM; appointment is for one year only.
- The positions on the Board are as follows: President, two Vice Presidents, Treasurer, and up to five additional Directors.
- The Articles of Association prescribe that there must be a minimum of six and maximum of nine Directors on the Board.
